MTSH released its annual report for FY 2023-24. According to its annual report, Myanmar-Japan Thilawa Development Ltd (MJTD) is currently implementing the deployment of solar photovoltaic (PV) system to generate electricity, aiming to reduce the dependance on fossil fuel and enhance renewable energy production. The initiative is projected to add 5 megawatts (MW) of electrical capacity. In Thilawa Garden City, solar power project (47.5 KWp) is installed by Thilawa Property Development (TPD) with grid tied system. Thilawa Property Development (TPD) is also preparing to develop “MSME Commercial Hub” project which makes progress toward the development of Micro, Small, Medium Enterprise (MSME) within Thilawa Special Economic Zone.
