Disclaimer Of Opinion By The Independent Auditor for FY 2023-2024 Financial Statements

The Disclaimer of Opinion was issued due to ongoing audit work related to one of the Group's component subsidiaries which has also caused the delay in the release of Financial Statements. Notwithstanding the Disclaimer of Opinion, the Board believes that the Group and the Company will be able to operate as a going concern.

Release of Annual Report for FY 2023-24

<u>Financial Service Sector</u>: Yoma Bank unveiled its new mobile banking application, "Next App" in March 2024. In addition, Yoma Bank reintroduced the Business Banking Portal, enhancing access to digital banking services for corporate customers.

<u>Health Care Sector</u>: The Heal by Pun Hlaing app, a groundbreaking digital health platform and the first of its kind in Myanmar, was publicly launched during FY 2023-24. It has already garnered 60,000 users.

<u>Real Estate Sector</u>: The "City Loft" project reached key milestones with the launch of its 10th tower (CL10) in March 2023 and its final 11th tower (CL11) in July 2023. Each tower, comprising 140 units, was fully sold out by the end of 2023. "City Villa" project totaling 207 villas, were also sold by the end of August 2023. "Estella Townhouse" project was a remarkable success, with 527 units sold within just two hours of the official launch. The new low-rise housing compound, "Ara", gained significant popularity among younger buyers, selling over 370 units in its first weekend of launch in March 2024. "City Loft West" the second tower (TC8), launched in September 2023, is nearly sold out, while the latest tower (TC2), introduced in January 2024, continues to attract buyers.

<u>Tourism Sector</u>: The prestigious Governor's Residence, a heritage hotel in downtown Yangon, reopened under the stewardship of the Memories Group, marking a key milestone in Myanmar's tourism revival.

In FY 2023-24, FMI achieved a revenue of 499.1 billion kyats, with a gross profit of 202.5 billion kyats and a net profit of 58 billion kyats. The earnings per share (EPS) for FMI stands at 1588 kyats.

Release of Management Discussion and Analysis

FMI's total revenue for the year FY2024 had gone from strength to strength by 47% to MMK 499.1 billion as compared to MMK 339.6 billion recorded in FY2023. Gross profit has also improved by 69.2% to MMK 202.6 billion in FY2024, as compared to MMK 119.7 billion in FY2023. FMI's net profit after tax for the year ended 31 March 2024 was increased to MMK 58.1 billion compared to MMK 4.1 billion for the year ended 31 March 2023. With this above result, the basic earnings per share ("EPS") was MMK 1,558 and the diluted EPS was MMK 1,247 in FY2024 which was well-ahead of the basic loss per share of MMK 21 in FY2023.

FMI's equity increased by 16.7% which is due to the favorable financial performance and profits are not distributed in favor for strategic growth of the Group.
