Release of Annual Report for FY 2023-24

In FY 2023-24, MADPL reported revenue of 4.4 billion kyats making a decrease of 9.6% and net gross profit of 37.7 million kyats, marking a significant decline of 89.5%, compared to the previous year. The company reported a net profit of 349.1 million kyats, reflecting a 32.3% decrease from the previous year. For FY 2023-24, MADPL's earnings per share (EPS) is 347 kyats.
